

Subject: **Regional Policy on the Administration of Quarterly Examinations in Public Schools**



1. In line with the quarterly examinations as contained in DepEd Order No 25, s. 2017 (School Calendar for SY 2017 – 2018), the regional office has issued a **Regional Policy on the Administration of Quarterly Examinations in Public Schools through Regional Order No. 1, s. 2017** which states the following:
 - that the quarterly examination measures whether learners have met the content and performance standards at the end of a period of learning. That in order for assessment to be more meaningful and authentic, teachers must use methods to measure student learning that have been deliberately designed to assess how well students have learned and able to apply their learning in different contexts;
 - only teacher made test shall be administered to the learners, **not** test constructed by assigned group in the division;
 - the results of the assessment test are **recorded and used** to report on the learner's achievements, the same are primarily reported to the learners and to the parents/guardians; and
 - quarterly examinations shall be monitored by the Regional and Division teams.
2. The administration of the First Quarter Examination in all public elementary and secondary schools will be on August 10 – 11, 2017. All school heads and teachers are expected to observe the standards in conducting quarter exams.
3. Immediate and widest dissemination of the contents of this Memorandum is enjoined.
