

1. The Department of Education Schools Division Office (through the Dagupan City Athletic Association) in partnership with Dagupan City Government (through the Dagupan City Sports Commission) hereby congratulates all the winners of the **MAYOR BELEN T. FERNANDEZ CUP 2017-DCAA Basketball and Volleyball tournament and 2017 DCAA Division Meet**. Likewise, Batang Pinoy Luzon Leg 2017 participants will also be recognized.
2. Closing Program and Awarding Ceremonies will be held on November 17, 2017 @ 7:00 am at CSI Jimmy Fernandez Stadia, Dagupan City.
3. There will be a Hip-Hop competition (Elem. & Sec.) during the program. See attached entry criteria, guidelines, and other forms for interested participants.
4. All Education Program Supervisors, Public Schools District Supervisors, School Directors, School Heads of Public and Private Schools, Technical Officials, Teachers, Coaches with their athletes and trainers/chaperones shall attend the above-mentioned event.
5. All participants are instructed to go back to their respective schools and resume classes immediately after the DCAA event and ensure catch-up activities to be in place.
6. The full support and cooperation of all concerned is desired.

**DAGUPAN CITY ATHLETIC ASSOCIATION (DCAA) MEET 2017
HIPHOP DANCE COMPETITION**

Entry Criteria:

The group must submit the following on or before **November 16, 2017 at 11:00 o'clock c/o Julie Contreras at Juan P. Guadiz Elementary School , AB Fernandez West, Dagupan City:**

1. Certificate of enrolment duly signed by the Principal/Registrar
2. Certified true copy of Form 137
3. Parents' Permit
4. Choreographer's/Trainer's Certificate of Employment

Place all these in a long folder and label it with your group's name. **Failure to submit said documents will disqualify the group from competing.**

(Do not use the name of your school).

Guidelines:

1. Each group per public/private school shall have a minimum of eight (8) and maximum of ten (10) members who may either compose of all male or female, or a combination of both aged 8-13 years old for elementary and 12 years old-above for secondary.
2. Performance should not exceed three (3) minutes. One (1) point shall be deducted for every five (5) seconds exceeding the limit. Timing of performance will start from the first note of the music and ends at the last note of the music (including entrance and exit).
3. Attire/costume must be decent and worn with comfortable shoes. Removing pieces of clothing during the performance is permitted provided it is not offensive or out of character.
4. **Dangerous routines (stunts, tumbling, throwing, body dropping, etc.) are not allowed to avoid any untoward accidents or injuries, and shall be ground for disqualification.**
5. Use of props is prohibited.
6. The trainer/choreographer should be a regular/contractual/substitute teacher or employee in the school being represented by the competing group.
7. Cash Prizes and certificates of recognition await the top three (3) winners.
8. The decision of the board of judges is final and Irrevocable.

Other Important Reminders:

1. The order of performance is determined by drawing of lots conducted by the committee before the start of the closing program on November 17, 2017 or on the scheduled blockings at CSI Stadia.
2. Submit your CD or USB (with the group's music only as content) to the facilitators of the competition (Chester Mark Malapit-Secondary and Tiffany Fermill-Elementary).
3. Report to CSI Stadia for blockings on Nov. 16, 2017 at 1:00 pm. (Pls. look for mam Marlene Mina, mam Marivil Cabaddu, mam Julie Contreras or sir William Morga)
4. All groups conforming with requirements will be allowed to compete.
