




SUBJECT : **CORRIGENDUM TO DIVISION MEMO NO. 181 "(REITERATING THE CONDUCT OF CY 2019 SECOND (2ND) QUARTER EARTHQUAKE DRILL**

DATE : June 13, 2019

1. This is to inform the field that the **Division Quarter 2 Earthquake Drill 2019** shall take place on June 19, 2019, preferably 8:00-9:00 o'clock in the morning instead of June 20, 2019, due to anticipated event (Agew na Dagupan) being commemorated in Dagupan City on June 20, 2019.
2. In addition, all Division Personnel are reminded of the following schedule of Quarterly Earthquake Drill to be facilitated by each Division (SGOD, CID & OSDS), simultaneously with schools. This is to ensure an increase in capacity of the personnel in handling emergency situations. The following shall be the **Division NSED facilitators**:
 - a) **Quarter 2, 2019 (June 19, 2019)** - SGOD (Team leader: Chief ES-SGOD with the Emergency Medical and Dental Health Services/other SGOD Personnel),
 - b) **Quarter 3, 2019 (August 8, 2019)** - CID (Team Leader: Chief ES-CID, with PSDS/EPS, other SGOD Personnel).
 - c) **Quarter 4, 2019 (November 14, 2019)** - OSDS (Team Leader: SDS, ASDS, Chief AO, with ICTO/Legal Office/Budget, Finance and Admin, other SGOD Personnel)

This shall form part of the capacity building of all Division Personnel in terms of preparedness in times of Disaster. **The Team Leader for Quarter 2 Earthquake Drill shall ensure of preparations prior to the conduct of the said drill in the division.**
3. Meanwhile, the Division shall deploy Monitoring Officials to Schools to ensure school compliance in the conduct of the earthquake drill. For this quarter, the Division DRRM Coordinator shall be with some SGOD staffs and the ALS Mobile Teachers. An **orientation for monitoring officials** will be conducted on **June 18, 2019 3 o'clock pm at the SGOD Office** to ensure they will be equipped on validation and post-evaluation on the conduct of the said event. *Please see attached list of Deployed Monitoring Officials for Quarter 2, 2019.*
4. All schools are encouraged to invite our DRRM Partner agencies, BDRRM Council and other DRRM partner Stakeholders/agencies to help during the Post-Evaluation Activity.
5. All schools are advised to make necessary preparations to ensure that the required reports are submitted on time.
 - SDO Monitoring officials are expected to submit the Office of the Civil Defense RO1 NSED Monitoring Tool at the Division through DRRM, while schools are expected to fill-up the NSED Data report (google form) to be sent through email, through the Division ICTO.
 - All **e-copy of schools report duly signed by the School Head** (with photos) shall be sent to the Division DRRM Coordinator at marjorie.rodriguez001@deped.gov.ph for consolidation, on or before June 21, 2019, 5 o'clock pm.
