The HRMPSB shall assist the SDS in the judicious and objective selection of candidates for appointment in accordance with their roles to include, but are not limited to, the following:

- Develop the System of Ranking Positions (SRP) which shall be submitted for approval of the appointing authority, copy furnished the CSC and its field offices for reference purposes;
- Recommend to the appointing authority the designation of sub-committee/s, as deemed necessary, to assist in the conduct of comparative assessment of applicants, and facilitate the evaluation process;
- Evaluate and deliberate the qualifications of all applicants in accordance with this policy, the provisions of the ORAOHRA, and relevant hiring guidelines;
- Make a systematic assessment of the qualifications and competence of applicants for appointment to the vacant positions;
- Develop and conduct further assessment such as written examination, skills test, BEI, and others, as deemed necessary;
- Submit to the appointing authority the CAR/ RQA, highlighting the top five (5) ranking candidates or less, and Minutes of Deliberation;
- Maintain fairness and impartiality in the assessment of applicants;
- Respond to queries and/or complaints pertaining to the comparative assessment results;
- Recommend areas of improvement to the DepEd Central Office, through proper channels, on the recruitment, selection, and placement policies;
- Perform other related functions as may be assigned




